DECISION

The assembly General of the African Mini Football Confederation,

Considering the statutes of the World Mini Football Federation (WMF) and the Statutes of the African Mini Football Confederation (AMC),

Considering the installation of the AMC executive board during the general assembly of March 3, 2018 in Tunis, which is composed of six members out of the regulatory total of eight members,

Considering the provisions of article 22 of the statutes of the African Mini Football Confederation relating to the prerogatives of the executive board and its composition,

Considering the revision of article 22 of the statutes of the African Mini Football Confederation by the extraordinary general assembly held in Ibadan, Nigeria on July 15, 2021, increasing the number of members of the AMC executive board from eight to ten, following the evolution of its activities and the continuous increase of member federations,

Considering the by-elections of the missing members made during the ordinary general assembly of the AMC held in Ibadan, Nigeria on June 9, 2021,

Decided:
